1. Are our proposals for the Annual Assurance Statement right?

Yes the approach is right and to be applauded in that it allows for Housing Associations to discuss openly with SHR any concerns they have regarding submitting their AAS this year as a result of the recent Pandemic.

However, it is our view that extending the deadline for submission for 1-2 months may be more appropriate than requesting the AAS Statements be submitted by 31 Oct 2020.

There are three reasons for this. One is that it is sympathetic and consistent with the approach to extend other deadlines for submissions to the SHR because of the unprecedented Pandemic and how it has effected workflows for organisations.

Secondly, the clear purpose of the AAS is for the Housing Association's benefit and for its committee members to 'own it' and be assured that decisions taken on behalf of the organisation are indeed the right ones. But for this year's submission it is understandable that HAs action plans developed as a result of last year's AAS submission could have been effected by the Pandemic and/or need to be revised because of it to ensure the AAS doesn't immediately become redundant and be of no help to Committee Members. This would merit a delay to ensure that can be reconsidered.

Finally, recent public health and government briefings on 'Easing out of Lockdown' caused by the spread of the virus have shown the fragile nature of this process. It is evident that Housing Associations will still be considering the 'live' risks of Covid-19 and its impact on its business through Sept /October which may make it difficult to provide the assurances of what they are doing is right as early as the 31st October.

2. Should we publish advisory guidance to assist landlords to adapt their approach to the submission of the AAS?

Yes. Guidance would help create a consistent approach for both parties (SHR and RSLs)
