

## **Registered Social Landlords' empty homes at 28 February 2025**

In February 2025 we asked all Registered Social Landlords (RSLs) to provide us with information on the level of empty homes / voids they had at 28 February 2025. We did this following a request by the Scottish Government asking us to collect this information on its behalf, to provide it with an up to date picture on empty homes / voids in social housing, and to allow it to better understand the potential contribution of bringing empty homes / voids back in to use in tackling the housing emergency.

This report provides a basic analysis of the information provided by RSLs. The <u>full data set is available here</u>.

We would like to thank landlords for their cooperation in providing this data.

## Main findings

- Of the total 305,100 homes provided by RSLs, 4,875 were empty on 28 February. This equates to 1.6% of total homes.
- 2,052, or 42%, of the total empty homes were normal lettable self-contained dwellings.
- 2,823, or 58%, of the total empty homes were empty for a specific reason, with the largest proportion of these being homes that were empty pending disposal, demolition or reconfiguration.
- Issues with delays caused by Utility Companies, resulting in properties sitting empty for months, was the common theme made by RSLs in the comments section - meter resets, exchanging meters and clearing debt on meters all took weeks/months for the Utility Companies to resolve and the properties could not be let out during this time.
- Table 1 shows the number of empty homes provided by RSLs by local authority area

In last year's <u>National Report on the Scottish Social Housing Charter</u> we reported that RSLs reduced the time taken to re-let empty homes to 39 days in 2023/24; this was down from 44 days in 2022/23, but not yet back to the low of 26 days in 2019/20.
